	RISK DUE TO	CHECK		ADVICES			
1	Slippery floors	YES	NO	Do not wax, particularly stairs			
2	Carpet placed on slippery floors	YES	NO	Use anti-slip carpet underlay, or remove if not necessary			
3	Bumpy, chipped or unstuck flooring or parquet	YES	NO	Repair			
4	Protruding steps or doorsteps	YES	NO	Make obstruction visible			
5	Climbable bookcases, drawers, or other furniture	YES	NO	Install latches on the drawers, change the structure, adequate supervision of child			
6	Wall units or bookcases not fixed firmly to the wall	YES	NO	Have them fixed to the wall			
7	Furniture with glass doors and mirrors	YES	NO	Install anti-shatter film			
8	Furniture with sharp corners at the height of the child	YES	NO	Use rubber corner guards (up to approximately 1 metre off the floor)			
9	Furniture with protruding bases or legs	YES	NO	Make obstruction visible			
10	No corner guards or radiator covers	YES	NO	Install adequate 1 metre high protection devices			
11	Presence of breakable glass and mirrors at the height of the child	YES	NO	Where possible, install anti-shatter film			
12	Presence of glass ornaments in a child's reach or on top of unstable furniture	YES	NO	Put in a safe place			
13	Presence of heavy household appliances (irons, televisions, computers or others) kept high up with the cables in the child's reach	YES	NO	Put in a safe place			
14	Presence of heavy objects (flower, plant, or other pots) placed high up on unstable stands	YES	NO	Put in a safe place			
15	Presence of plants with thorns, spiky or poisonous leaves	YES	NO	Put in a safe place			
16	Presence of unsafe electric sockets	YES	NO	Without socket protectors or "safety" caps			
17	Presence of electric sockets, overloaded with connected appliances	YES	NO	Use a multiple socket			
18	Presence of damaged electrical appliances or power cables	YES	NO	Replace			
19	No high sensitivity circuit breaker	YES	NO	Installation is necessary			



## ROOMS

### ENTRANCE

	RISK DUE TO	YES	NO	ADVICES	ALREADY DONE	UNDER CONTROL
20	Flight of stairs in front of the entrance, with a very narrow landing	YES	NO	Pay attention when manoeuvring the pushchair		

### LIVING ROOM

21	Fireplace without adequate protection from the heat or from the flames	YES	NO	The need for adequate protection (fire screens), or supervision of child near a lit fire		
22	Presence of folding chairs dangerous because they may crush child	YES	NO	Stow away in places inaccessible to the child		

### KITCHEN

23	Unprotected cutting utensils, easily reached by the child	YES	NO	Use latches for the drawers		
24	Electrical appliances for cutting, or under power blenders, in the child's reach	YES	NO	When not in use, always unplug the appliance		
25	Gas cooker without the thermocouple (a thermocouple is an optional device)	YES	NO	Keep an eye on cooker as to avoid the release of gas in the event of the flame going out		
26	Oven positioned at the height of the child, thus easy to open	YES	NO	Install a safety catch and keep an eye on the child		
27	Improper use of the cooker, with pan handles that are too long	YES	NO	In the presence of children, it is advisable to make a habit of using the rings closest to the wall, remembering to turn the handles inwards		
28	Dishwashers that open at child height	YES	NO	Keep a watchful eye to avoid steam burns, etc		
29	No or incorrect use of natural ventilation system (permanent opening)	YES	NO	There must be one and it must be free of obstruction		

### CHILDREN'S ROOM

30	Bed without sides, or with too greater distance between the vertical bars	YES	NO	The space between the vertical bars must be < 8cm , and the bars must also be protected by soft material		
31	Baby changing table that is unstable and/or has inadequate side protection	YES	NO	Fix, or if unstable, replace. Always keep an eye on the child on the changing table		
32	Soft mattress, and an abundance of cushions and covers which can cause risk of suffocation	YES	NO	Remove them; use anti-suffocation cushions		
33	Presence of doors locks that close on the inside	YES	NO	Remove the key		
34	Platform or bunk bed	YES	NO	Possibly avoid, or protect with adequate apparatus		
35	Units with closable shutters with locks	YES	NO	Remove the key		
36	Presence of wall or table lamps and clock radios accessible to the child	YES	NO	Fix/move or supervise adequately		
37	Presence of electric fires, thermal blankets, etc...	YES	NO	Remove		

# ROOMS

## BATHROOM

	RISK DUE TO	CHECK		ADVICES	ALREADY DONE	UNDER CONTROL
38	No water temperature regulation (thermostat, inattention,...)	YES	NO	Always check the water temperature before putting the baby in the water		
39	Presence of electric boiler	YES	NO	Make sure it is installed at a safe distance from the bath or shower		
40	Slippery mats and rugs near bathroom fixtures	YES	NO	Carpets can be useful for not slipping on wet floor – use anti-slip bath mats		
41	Presence of electric heater near the bath, shower, wash-basin or bidet	YES	NO	It should not be in reach of who is using the bathroom		
42	Presence of hair-dryer close to the bath, shower, wash-basin or bidet	YES	NO	It should not be in reach of who is using the bathroom		
43	No ventilation system, if necessary (e.g. when an open vent heater or gas boiler present)	YES	NO	There must be one and it must be free of obstruction		

## STAIRS

44	No second banister at height of child	YES	NO	Put banister in place, at approximately 45-50cm from the floor, or supervise the child		
45	The banister can be climbed over by a child	YES	NO	Put a protective net		
46	The vertical bars are too large	YES	NO	The space between the vertical bars must be < 10cm. Put a protective net		
47	Absence of baby gate which prevents the child accessing the stairs	YES	NO	Install baby gate or watch the child		

## BALCONIES, TERRACES AND LOFTS

48	The railing or bannister can be climbed by a child	YES	NO	Put a protection net. Even flower boxes can be used as a staircase		
49	The railing or banister are easily climbed over by a child	YES	NO	Put a protective net. The vertical spaces must be < 10cm		
50	Easily movable and climbable furniture	YES	NO	Remove if necessary		

## DOORS AND WINDOWS

51	Dangerous collision of doors opening simultaneously	YES	NO	Block or remove one door		
52	Window or door frames are metal, and thus have sharp corners	YES	NO	Put rubber corner guards		
53	The lower part of windows and doors are not made of shatter-proof glass, with the danger of being rushed into	YES	NO	Replace or put appropriate protection		
54	Presence of climbable objects beneath the windows	YES	NO	Remove or put in a safe place		
55	Excessively long curtain cords	YES	NO	Remove		
56	Window with shutters which do not have fixtures for closing	YES	NO	Fit

### COURTYARD AREA

	RISK DUE TO	CHECK		ADVICES	ALREADY DONE	UNDER CONTROL
57	Potholes, gutters, drains, water tanks and any other accessible openings that are unguarded	YES	NO	Close		
58	Paving, soil, or any other loose handiwork	YES	NO	Fix and level		
59	Visible work tools, easily reached by children	YES	NO	Put them in a place inaccessible to the child		
60	Work tools mixed together with children's toys	YES	NO	Keep them separate. Stow the work tools in a place inaccessible to the child		
61	Outdoor BBQ with too large a mesh	YES	NO	Install a BBQ with a mesh of < 2cm, approximately		

## BEHAVIOUR

	RISK DUE TO	CHECK		ADVICES	ALREADY DONE	UNDER CONTROL
62	Presence of detergents, cleaning and hygiene products for the house, insecticides, or other poisonous or dangerous substances in child's reach	YES	NO	To be placed in cabinets held closed with a key, or high up and inaccessible to children		
63	Presence of medicines in child's reach	YES	NO	To be placed in cabinets closed with a key, or high up and inaccessible to child		
64	Presence of plastic sacks and bags	YES	NO	Keep them in a place inaccessible to the child		
65	Presence of sharp or pointed objects left unattended	YES	NO	To be placed in closed cabinets or in places inaccessible to the child		
66	Child alone near lit stove or fireplace	YES	NO	Supervision necessary		
67	Child alone on baby-changing table or parent's bed	YES	NO	Supervise		
68	Presence of small toys or other objects accessible to children	YES	NO	Remove and supervise child		
69	No precise check of temperature of baby bottle or food before feeding	YES	NO	Always check the temperature of the food before feeding		
70	No precise check of water temperature before the child's bath	YES	NO	Always check before bathing the child		
71	Use of electrical appliances near water, with wet hands or on wet floors, or during the child's bath	YES	NO	Avoid use in such condition
